COMMISSIONERS COURT RESOLUTION ACCEPTING GRANT ADJUSTMENT NOTICE #2 FOR THE LOCAL BORDER SECURITY PROGRAM FY 2010/2011 (LBSP-11)

WHEREAS, the Nueces County Commissioners Court finds it in the best interest of the citizens of Nueces County to apply for the Local Border Security Program FY 2010/2011 (LBSP-11) through the Texas Rangers Division of the Texas Department of Public Safety.

WHEREAS, on March 23, 2011, the Commissioners Court approved the submission of a grant application for the Local Border Security Program FY 2010/2011 (LBSP-11).

WHEREAS, the Local Border Security Program FY 2010/2011 (LBSP-11) is funded to provide additional manpower by local law enforcement agencies for state led border security enhanced operations for improved border security.

WHEREAS, the Commissioners Court accepted a Notice of Grant Award for \$93,600 on April 20, 2011 and designates the County Judge as the grantee's authorized official. The authorized official is given the power to apply for, accept, reject, alter or terminate the grant on behalf of the applicant agency.

WHEREAS, the Commissioners Court accepted Grant Adjustment Notice #1 to extend the performance period end date to August 31, 2012.

WHEREAS, the Commissioners Court has received Grant Adjustment Notice #2 to extend the performance period end date to December 31, 2012.

NOW, THEREFORE, BE IS RESOLVED that the Nueces County Commissioners Court accepts Grant Adjustment Notice #2 for the Local Border Security Program FY 2010/2011 (LBSP-11) to extend the performance period end date to December 31, 2012.
