
Please find enclosed Wesley Community Center's reports for the funding approved by Nueces County Commissioners Court April 25, 2012, Contract #20120072, for the County's FY 2011/2012.

This funding was designated for our programs that provide services to and support of children in need of protection and care in Nueces County and for promoting diabetes awareness and prevention in Nueces County by providing public access to information concerning prevention techniques, healthy diets, exercise, maintaining proper control of diabetes, and economical healthy meal planning.

We are pleased to report that the \$2,000 in funding from Nueces County Commissioners Court has helped us to provide 2,296 families with emergency food and diabetes educational materials via our Food Pantries in Robstown and Corpus Christi from September 1, 2011 through July 31, 2012. Additionally, we have been able to serve 24,225 healthy, nutritious meals during this same time frame to the low-income, homeless, and CPS children in our care.
