**AMENDMENT NO. 1 TO
NUECES COUNTY TAX ASSESSOR-COLLECTOR
DTA AGREEMENT
Motor Vehicle License Point of Sale Sticker Lease
With
CHAMPION HYUNDAI**

WHEREAS, Nueces County and the Nueces County Tax Assessor-Collector entered into a DTA Agreement (“Agreement”) with Champion Hyundai on November 17, 2006;

WHEREAS, pursuant to the Agreement Champion Hyundai agreed to maintain a bond for \$80,000.00 and upon its posting a certain amount of sticker receipts, plates and receipts (“Inventory”) would be issued;

WHEREAS, Champion Hyundai has requested an increase in the amount of Inventory issued necessitating an increase in the bond amount;

WHEREAS, the Agreement provides that it may be amended in writing;

NOW THEREFORE, paragraphs 8 and 9 as set out under Distributor responsibilities of the Agreement are amended to read as follows:

8. In order to guarantee the faithful performance of the duties of the Distributor hereunder and to insure that all funds coming into the possession or control of the Distributor by virtue of this agreement are paid over to the Tax Assessor-Collector, the Distributor agrees to post a surety bond issued by a surety company or financial institution acceptable to that Tax Assessor-Collector in the amount of \$100,000.00 per dealership, naming the Nueces County Tax-Assessor Collector as an obligee on said bond.

9. Extend the bond on an annual basis; renew the bond before the expiration date thereof and forward a copy of such renewal to the Tax Assessor-Collector. If bond is cancelled for any reason or will be cancelled Distributor agrees to notify the Tax-Assessor immediately. Upon posting of said bond the Distributor shall be entitled to the issuance of Sticker receipts, passenger/ truck plates, and form 31s receipts pursuant to paragraph 2 hereof in any combination which total supply value shall not exceed the bond amount posted as per paragraph 8.

All other provisions of the Agreement remain the same.
