

NUECES COUNTY HISTORICAL COMMISSION

DUTIES:

Shall be to preserve, protect and promote history within the county and make recommendation to County Commissioners Court for property acquisition, which is of historical significance to the County; support and promote, whenever possible, the programs of the Texas Historical Commission. Conduct programs of Historical marker recommendations and placements.

COMPOSITIONS:

Any resident of Nueces County recommended by the Nueces County Historical Commission or the Commissioners Court, and approved by the Commissioners Court shall be eligible.

CREATION AND AUTHORITY:

In accordance with the Section 1 (b), Article 6145.1 Vernon’s Civil Statues, now Chapter 318 of the Texas Local Government Code.

MEETS:

Second Tuesday of every month, at 5:15 p.m. in the second floor meeting room at the Corpus Christi Public Library, Corpus Christi, Texas.

TERMS: Two year terms with board positions expiring in December of even-numbered years.
