AGREEMENT AMENDMENT NO. 2

WHEREAS, the County of Nueces and Bay Ltd., entered into an Agreement on February 23, 2011, for Hot Mix Asphaltic Concrete Type D PG 64-22 (IFB No. 2869-10); and Amendment No. 1 to the Agreement on January 4, 2012.

WHEREAS, the parties now want to exercise the option as set out in Article II of the Agreement to extend the term of the Agreement;

WHEREAS, Bay Ltd., provided notice of a price escalation of 5%, the maximum amount of increase allowed, as set out in Article I of the Agreement;

NOW, THEREFORE, Nueces County and Bay Ltd., in consideration of the mutual agreements contained in the original Agreement and additional time provided pursuant to this amendment do hereby mutually agree:

1. To exercise the renewal option of 12 months as set out in Article II of the Agreement extending the terminate date of the Agreement to February 23, 2014.
2. To increase costs by 5% effective February 23, 2013. The cost difference is:
 - a) With freight included: Item previous cost per ton \$64.00, new cost \$67.20;
3. All other provisions of Agreement shall remain the same.

IN WITNESS WHEREOF, the parties hereto, intending to be legally bound, have duly executed this Amendment duplicate.

Annette:

After further review I am able to offer the following.

Original bid price = \$60.95 ton
Today's bid price = \$60.95 + 5% = \$64.00 ton

The asphalt at bid date was \$425.00 ton. Today's asphalt price is \$550.00 per ton. The difference in the two asphalt prices is \$125.00 ton. Our hot mix requires 5% asphalt which causes an increase of \$125.00 ton x 5% = \$6.25 ton.

Original bid price = \$60.95 ton + \$6.25 ton = \$67.20 ton Today's bid price = \$64.00 ton Proposed bid price = \$64.00 ton + 5% = \$67.20 ton

The price of \$67.20 ton is an increase of 5% from last year and the increase in our asphalt costs justify the increase in the price of hot mix.

Attached is our price quotes on the cost of asphalt at original bid date and the cost of asphalt today.
