**AMENDMENT NO. 2 TO
NUECES COUNTY TAX ASSESSOR-COLLECTOR
DTA AGREEMENT
Motor Vehicle License Point of Sale Sticker Lease
With
AN Corpus Christi Chevrolet LP**

WHEREAS, Nueces County and the Nueces County Tax Assessor-Collector entered into a DTA Agreement (“Agreement”) with Champion Chevrolet Cadillac, AN Corpus Christi Chevrolet LP on October 12, 2005;

WHEREAS, Nueces County and Champion Chevrolet Cadillac, AN Corpus Christi Chevrolet LP entered into an Amendment No. 1 of this Agreement on November 21, 2012;

WHEREAS, AN Corpus Christi Chevrolet LP has changed their trade name from Champion Chevrolet Cadillac to AutoNation Chevrolet Cadillac South Corpus Christi;

WHEREAS, the parties want the Agreement to accurately reflect AN Corpus Christi Chevrolet LP new trade name (d/b/a) of AutoNation Chevrolet Cadillac South Corpus Christi and include d/b/a AutoNation Buick GMC Corpus Christi into Agreement;

WHEREAS, the Agreement provides that it may be amended in writing;

NOW THEREFORE, all references to Champion Chevrolet Cadillac throughout the Agreement are now changed to read AutoNation Chevrolet Cadillac South Corpus Christi. AutoNation Buick GMC Corpus Christi is an assumed name of AN Corpus Christi Chevrolet LP and by agreement of the parties is subject to this Agreement. Exhibit “A” is herein replaced with Exhibit “A-1” herein attached and incorporated in its entirety.

All other provisions of the Agreement not contrary to amendments made herein remain the same.

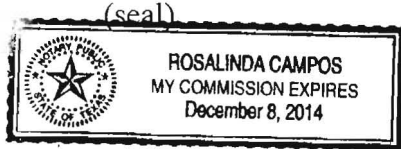

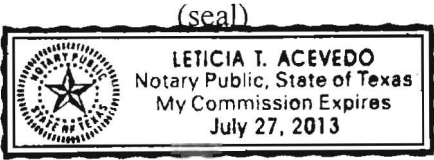
