AGREEMENT AMENDMENT NO. 1

WHEREAS, the County of Nueces (“**Client**”) and FasClampitt Paper Store, entered into an Agreement on the effective date, September 5, 2012, for Copy Paper, Computer Paper, NCR Paper, and Envelopes (IFB No. 2909-12);

WHEREAS, the parties now want to exercise the option as set out in Article II of the Agreement to extend the term of the Agreement;

WHEREAS, FasClampitt Paper Store is requesting a price escalation for three (3) items as set out in Article I of the Agreement;

NOW, THEREFORE, Nueces County and FasClampitt Paper Store, in consideration of the mutual agreements contained in the original Agreement and additional time provided pursuant to this amendment do hereby mutually agree:

1. To exercise the renewal option of 12 months as set out in Article II of the Agreement extending the termination date of the Agreement to September 4, 2014.
2. To increase costs for 3 items by 6% each by giving County 30 day written notice prior to agreement anniversary date, as set out in Article I of the Agreement. The 3 items are:
 - a). Item #3.1 previous cost \$69.75; new cost \$73.94;
 - b). Item #3.2 previous cost \$78.75; new cost \$83.48;
 - c). Item #3.3 previous cost \$84.15; new cost \$89.20;
3. All other provisions of Agreement shall remain the same.

IN WITNESS WHEREOF, the parties hereto, intending to be legally bound, have duly executed this Amendment in duplicate.
