## AGREEMENT AMENDMENT NO. 2

**WHEREAS**, the County of Nueces ("**Client**") and Amtex Security, Inc. entered into an Agreement on the effective date, July 25, 2012, for Security Services for the Courthouse, Juvenile Center and Keach Library (RFP No. 2908-12).

**WHEREAS**, Coastal Parks is requesting security service to patrol the piers, campgrounds and parks during the weekends and two holidays (4<sup>th</sup> of July and Labor Day) for the Padre Balli and I.B. Magee Parks;

**NOW, THEREFORE**, Nueces County and Amtex Security, Inc. in consideration of the mutual agreements contained in the original Agreement do hereby mutually agree:

1. To provide security services for 10 consecutive weekends from June 28, 2013 to September 2, 2013 including two holidays (4<sup>th</sup> of July and Labor Day).
2. To provide four 12 hour shift per weekend (48 hours) at the bid hourly rate for unarmed security service of \$11.80. Shift will start at 7:30 am on Friday and end at 7:30 pm Sunday.
3. To provide two 12 hours shifts per holiday (24 hours) at the hourly rate for unarmed security service of \$17.70. Shift will start at 7:30 pm the day of the holiday to 7:30 pm the following day.
4. To provide one individual per shift who will patrol the piers, campgrounds, and parks for illegal activity and overnight security of the parks.
5. To provide one security vehicle at \$7.00 an hour with light bar on vehicle roof and AMTEX Security insignia on the vehicle doors.
6. Coastal Parks will supply AMTEX security guard with a County radio.
7. All other provisions of Agreement remain the same.

Thank you for considering AMTEX Security for contract services. The following quote is for 10 consecutive weekends of Security Patrol for Coastal Parks. We appreciate being requested to do more security work for Nueces County.

Term: **June 28, 2013 – September 2, 2013**

Contract Security Officer Labor Rate

- Private Security Rate of \$11.80 per hour; Holiday Rate = \$17.70 per hour

Total Hours of Contract Security per Weekend

- 48 hours (Four 12-hour shifts starting from 7:30pm Friday to 7:30pm Sunday)
- 48 hours (Fourth of July 7:30pm to 7:30pm and Sept.2 Labor Day 7:30pm to 7:30pm )

Total 48 plus 48 Hour Billing Total for Contract Security Labor

- 48 hours x \$11.80 per hour = \$566.40; 4th of July Cost = 24 hours x \$17.70 = \$424.80 and Labor Day 24hours x \$17.70 = \$424.80.

Total Hours of Contract Security Vehicle per Weekend

- 48 hours (From 7:30pm Friday to 7:30pm Sunday)

Total 48 Hour Billing Total for Contract Security Vehicle

- 48 hours x \$7.00 per hour = \$336.00 plus 48 hours for 4<sup>th</sup> of July/Labor day = \$336.00

**TOTAL Cost for 10 (48-Hour) Weekends and 4th of July/Labor Day of Contract Security Services = \$10,211.60**

Any additional labor or vehicle hours outside this scope of agreement must be approved at least 24 hours in advance by AMTEX Security.

AMTEX will provide any increases or decreases of security based on the particular threat or needs of Coastal Parks, when requested. Coastal Parks will supply AMTEX guards with a radio and AMTEX will provide a Security Vehicle with Light Bar on vehicle roof and AMTEX Security insignia's on vehicle doors. Main duties will include patrolling the parks for illegal activity and overnight security of the park.
