**RESOLUTION OF NUECES COUNTY AUTHORIZING THE FILING OF A GRANT APPLICATION WITH THE COASTAL BEND COUNCIL OF GOVERNMENTS FOR A REGIONAL SOLID WASTE GRANTS PROGRAM GRANT; AUTHORIZED THE COUNTY JUDGE TO ACT ON BEHALF OF NUECES COUNTY IN ALL MATTERS RELATED TO THE APPLICATION; AND PLEDGING THAT IF A GRANT IS RECEIVED, NUECES COUNTY WILL COMPLY WITH THE GRANT REQUIREMENTS OF THE COASTAL BEND COUNCIL OF GOVERNMENTS, THE TEXAS COMMISSION ON ENVIRONMENTAL QUALITY, AND THE STATE OF TEXAS**

**WHEREAS**, the Coastal Bend Council of Governments is directed by the Texas Commission on Environmental Quality to administer solid waste grant funds for implementation of the COG's adopted regional solid waste management plan; and

**WHEREAS**, Nueces County in the State of Texas is qualified to apply for grant funds under the Request for Applications.

**NOW, THEREFORE, BE IT RESOLVED BY NUECES COUNTY IN CORPUS CHRISTI, TEXAS:**

1. That the County Judge is authorized to request grant funding under the Coastal Bend Council of Governments Request for Applications of the Regional Solid Waste Grants Program and act on behalf of Nueces County in all matters related to the grant application and any subsequent grant contract and grant project that may result.
2. That if the project is funded, Nueces County will comply with the grant requirements of the Coastal Bend Council of Governments, Texas Commission on Environmental Quality, and the State of Texas.
3. The grant funds and any grant-funded equipment or facilities will be used only for the purposes for which they are intended under the grant.
4. That activities will comply with and support the adopted regional and local solid waste management plans adopted for the geographical area in which the activities are performed.
