AGREEMENT AMENDMENT NO. 2

WHEREAS, the County of Nueces (“**Client**”) and Corpus Christi Disposal Service (a division of Texas Jack Waste Holdings, Inc.), entered into an Agreement on the effective date, October 23, 2013, for Solid Waste Collection & Disposal Service (Dumpster) for County Properties Only (IFB No. 2937-13); and Agreement Amendment No. 1 on August 19, 2015;

WHEREAS, the parties now want to exercise the option as set out in Article II of the Agreement to extend the term of the Agreement for one year;

NOW, THEREFORE, Nueces County and Corpus Christi Disposal Service, in consideration of the mutual agreements contained in the original Agreement providing for a contract renewal term do hereby mutually agree:

1. To exercise the renewal option of 12 months as set out in Article II of the Agreement extending the termination date of the Agreement to October 23, 2017.
2. All other provisions of Agreement shall remain the same.
