**SUPPLEMENTAL AGREEMENT NO. 1  
BETWEEN  
NUECES COUNTY AND CLK ARCHITECTS & ASSOCIATES, INCC.**

**WHEREAS**, Nueces County and CLK Architects & Associates, Inc. entered into an Architectural Services Contract on January 6, 2016, herein referred to as "Contract", for the preparation of plans, specifications and construction phase services for ADA modifications at fourteen (14) county facilities; and

**WHEREAS**, Article 11 of the Contract establishes the method for changes in the scope, complexity, character, or duration of the services to be provided; and

**WHEREAS**, an extension of the Contract termination date is needed to coincide with the revised termination date of the Settlement Agreement for ADA compliance with the U.S. Department of Justice.

**NOW, THEREFORE**, Nueces County and CLK Architects & Associates, Inc. in consideration of the mutual agreements contained in the original Contract, do hereby mutually agree:

1. The second sentence of Article 4 - Contract Period is hereby withdrawn in its entirety and replaced with the following:

"This Contract shall terminate at the close of business on September 30, 2021, unless extended by supplement agreement duly executed by the Architect and County prior to the date of termination, as provided in Article 11 - Supplemental Agreements, or otherwise terminated, as provided in Article 20 - Termination."

2. The first sentence of Article 20 - Termination is hereby withdrawn in its entirety and replaced with the following:

"This Contract shall terminate at the close of business on September 30, 2021, unless extended as provided in Article 11 - Supplemental Agreements."

3. All other provisions of the Contract shall remain the same.
